In connection with the conduct of Project Viva-Voce Examinations in the academic year– (2025-26) for RA15, RA18 regulation, students are informed that the payment of Project viva-voce exam fee. The project viva-voce exams should be conducted as per instructions mentioned below:

- The student is permitted to submit Project, only after successful completion of all theory and practical courses.
- No penalty may be levied to the student if the student submits project within one calendar year after completion of penultimate semester (6 months from the last semester). If the student is unable to submit the project within one calendar year, a penalty of Rs.5000/- will be levied for the first year of late submission, Rs.12000/- will be levied during second year of submission and Rs.18000/- will be levied during third year of submission. A special permission can be granted by the Controller of Examination to a student for submission of project beyond three years limit with a penalty of Rs.10,000 per year additionally.
